COST OF ATH SERVICES

- No individual who meets admission requirements will be turned away due to inability to pay.
- → The ATH does accept Community Living Waivers (CL Waiver), if applicable.
- → Otherwise, a security deposit of 30% of the individual's income is required, and monthly rent is 70% of the individual's income.

LENGTH OF STAY

Length of stay is determined by individual need and the treatment plan; there is no minimum or maximum.

- → A 6-month lease is signed upon admission.
- If the individual leaves before the lease term ends, the lease is discontinued at discharge with no remaining balance owed.

WHO WE ARE

The Adult Transition Home (ATH) provides a supportive residential setting for adults who need a place to live while building independence and developing a community-based support plan. The ATH can accommodate up to six individuals at a time in a comfortable, home-like environment.

Our **multidisciplinary team** offers skill-building and group home supports for adults with an Intellectual and/or Developmental Disability (ID/DD) diagnosis. Staff are cross-trained to support individuals with ID/DD who also have co-occurring mental health conditions and/or behavioral challenges.

The ATH collaborates closely with REACH crisis programs across the state to support individuals in their transition into the community.

With the **goal of promoting long-term stability**, the ATH partners with Community Services Boards, REACH Crisis Therapeutic Homes, and state hospitals to provide a seamless stepdown option for continued care.


The ATH meets all Home & Community-Based Services (HCBS) Rights and Responsibilities and adheres to all state licensing standards.

ADMISSION CRITERIA

- Age 18 or older
- Have a qualifying Developmental Disability diagnosis
- Experiencing a barrier to a step down from a REACH Crisis Therapeutic Home, state hospital, jail or prison, or a private hospital



ADMISSION PROCESS

Professional referral sources must complete a **Referral Package** which can be requested by contacting **804-312-8250**, ATH main phone.

The Referral Package includes:

- ATH Referral Form
- Psychological Assessment/Evaluation or other Eligibility Documentation
- Behavior Plan (if applicable)
- Client Information Sheet
- Guardianship Documentation
- Release(s) of Information
- Crisis Education and Prevention Plan (CEPP) if the individual currently receives REACH services
- Regional Support Team Referral Form

The completed Referral Package will be reviewed by the **Admission Advisory Committee (AAC)**. Once the ACC confirms that Admission Criteria have been met, the referral partner will be asked to submit some additional documentation:

- Risk Assessment
- Signed Medical Orders
- TB Results and Medical Screening
- Behavior Support Plan (BSP), if applicable
